MINUTES OF THE MEETING

Minutes of the meeting of Board of Under-Graduate Studies in Favironment and Water Management and Module Course in Environmental Studies held on 10/11/2012 at 10:30 am

- Agenda: 1. Re-designing of syllabus of vocational course in Environment and Water Management for single paper scheme
 - 2. Re-designing of syllabus for module course in Environmental Studies for single paper scheme

The Board of Under-Graduate Studies meeting was held on 10th November, 2012 at 10.30 am under he chairmanship of Prof. Sheikh Javid, Dean Physical and Material Sciences in the office chamber of HoD Environmental Science. The Chairman of the Board of U.G. Studies welcomed the members and declared the meeting open. The members were granted a mandate as per guidelines for only Redesigning/rearrangement/reshuffle of the course contents of Environment and Water Management (paper A and B) in order to merge in a single paper which in no case should affect the quantum of presently prescribed syllabus for the paper A and B. Different suggestions were proposed during the meeting some of which were unanimously agreed. Reshuffle and restructure of some topics over the whole syllabus was felt necessar, and agreed upon. However it was resolved that:

- 1. Topics as per the proper placement and relevance be merged/shifted/integrated under the new unit titles across the three year course.
- 2. Titles of some of the units be changed because of the merging of units/topics into a single paper system.
- 3. Some latest books regarding the subject matter be incorporated in the bibliography
- 4. The Syllabus be implemented from batch 2013 onwards.
- 5. Practical part also needed a slight rearrangement/reshuffle.

As per the unanimous decision of the members, the recommended changes in the form of reshuffle and restructure were incorporated in the Syllabus for batch 2013 and onwards without affecting the quantum of presently prescribed syllabus for the paper A and B.

In case of the contents of module course of Environmental Studies experts/members of the board have agreed to incorporate new Unit (Unit V) entitled Environmental Education and Legislation wherein topics from other units were put in place.

Further resolved that the Environmental studies be made compulsory at every level in undergraduate programmes inclusive of B. Tech, B. Phramacy, B.Sc. IT, BBA, MBA (Integrated) etc in light of the Hon'ble Supreme court directive which applies to all States and Union Territories and its compulsory implementation in all the University/Colleges of India.

Ganai, HOD, Environmental Science in the office chamber of HOD Environmental Science. The Chairman of the Board of P. G. Studies welcomed the members and declared the meeting open. The members were granted a mandate as per guidelines of Choice Based Credit System to draft the Syllabi contents. Different suggestions were proposed during the meeting some of which were unanimously agreed. Major reshuffle and restructure of some papers/units/topics over the whole syllabus was felt necessary and agreed upon. However it was resolved that:

- 1. Syllabi were framed as per the scheme of CBCS.
- 2. Topics as per the proper placement and relevance were merged/shifted /integrated under the new papers /new unit titles across the two year course.
- 3. Titles of some of the papers/units were changed because of the merging of papers/units as per the CBCS.
- 4. Some new papers were floated as per the scheme and availability of faculty and accordingly the relevant and latest books regarding the newly introduced papers and subjects be incorporated in bibliography.
- 5. The Syllabi be implemented from batch 2015 onwards.
- 6. Practical part was framed as per the contents of the theory papers and should form a part of Core credits and project work (Dissertation) was specially kept for fourth semester in the core credit.

As per the unanimous decision of the members the recommended change in the form of reshuffle and restructure were incorporated in the syllabus for the batch 2015 and onwards.

It was also recommended by the experts that additional emoluments should be paid for teaching open credits to the concerned teachers.

The meeting ended with a note of thanks to the Chair.
