**Minutes of Board of Post Graduate Studies meeting held on 27-06-2019 at 12 Noon am in the office Chamber of Head, Department of Environmental Science, University of Kashmir**

**Agenda: - Framing/Restructuring of syllabus for PG Environmental Science under new CBCS scheme**

1. The Board of Post Graduate Studies meeting was held initially on 9<sup>th</sup> of April, 2019 at 10:30 am under the chairmanship of Prof. B. A. Ganai, HoD, and Environmental Science in the office chamber of HoD Environment Science. Internal faculty members in the said meeting were entrusted to prepare the syllabi as per the suggestions/discussions agreed in the meeting and present the changes in whole syllabi on priority to the all members in next meeting before submitted to competent authorities for its approval and uploading on website. The next meeting in this regard was convened on 27/06/19 wherein major reshuffle and restructure of some papers/units/topics over the whole syllabus earlier agreed upon was given a final shape. It was further resolved that:-
2. Syllabi be framed as per the revised scheme of Choice Based Credit System.
3. Eight credits in the core course were introduced and incorporated into II and III semester respectively while as Project dissertation was raised to 12 credits in the core syllabi at fourth semester.
4. New course titled Environmental Economics and Sustainable development was introduced in II semester as DCE.
5. Environmental Biotechnology and Environmental Microbiology were clubbed together to form four credits of DCE in third Semester.

The meeting ended with a vote of thanks to the chair.





**Agenda:** Finalising the syllabus of “Environmental Science” under NEP-2020

A joint meeting of Boards of Under-Graduate Studies and Post-Graduate Studies in “**Environmental Science**” under NEP-2020 together was held on 9 & 10 November 2023 which was in continuation of the previous meeting held on 23 June 2023 for preparation of Water Management syllabus which was recently been introduced as major/ minor subject at the undergraduate level in various colleges of Kashmir. There was enough discussion and deliberation on this newly introduced subject and the related issues thereof. All worthy members have actively participated in deliberations and discussion that could make this exercise very fruitful. After a threadbare discussion among members throughout the two day meeting, following points/items were resolved.

1. That this syllabus will be effective from 2024 batch and onwards; however, the syllabus for 2022 and 2023 batches will remain the same from 1-3 semesters.
2. That this syllabus complete in all respects has been prepared in one go to avoid overlaps with suggested readings for the benefit of the student and teacher community.
